<p>A rating appeal for the Tartan 10 was submitted by a Competitor. The committee reviewed the information sent in, including race results. The committee looked at how all Tartan 10's are performing, not just Whisper. While Whisper does consistently win their races, other Tartan 10's are not consistently in the top half of the fleet. Unfortunately, the committee cannot change a base rating for a boat based on the performance of one boat with an experienced skipper/crew when other boats of the same type are not also consistently winning.</p> <p>Appeal Denied. Base rating for the Tartan 10 remains 126.</p>
